

**COMMITTEE ON CONTINUING LEGAL EDUCATION CERTIFICATION
YEAR 2008 - 2009**

CLE Requirements

Every active lawyer in the Commonwealth shall complete twenty (20) hours of Continuing Legal Education (CLE) for 2008 and 2009 calendar years. Attorneys may carry over a maximum of five (5) CLE Credit hours to the next reporting period which will be for the 2010 and 2011 calendar years. Attorneys admitted after July 1, 2002, shall also attend and complete a course in Professionalism sponsored jointly by the Commonwealth Supreme Court and the CNMI Bar Association.

Reporting CLE Credit

CLE credits shall be reported every two years on or before **February 15**. The report is due at the CNMI Bar Association on **February 15, 2010**. Attached is a worksheet to list activity complying with Judicial Administrative Order No. 2001-502.1 (http://www.cnmilaw.org/pdf/court_rules/R15.pdf).
